Subject: INTERNAL ADMINISTRATIVE INTERVENTION (requests)

Dear Ma'am,

As you are aware of the media stations in this country, the signatory has been involved - without proof, in the tragic murder of my companion Kyriakos Amiridis - Ambassador and Plenipotentiary Minister, held in Rio de Janeiro when we were in leave of Christmas festivities.

First of all, I DECLARE INNOCENT to the people of the Greek Hellenic Republic, being the victim of an accelerated, unjust and disconnected police investigation, all in violation of the law, as will be proved in due course.

The facts are still being investigated, and due process has not yet occurred, and in Brazil, according to its current Federal Constitution:

"No one shall be held guilty until a final judgment is passed." In other words, there is presumption of innocence provided for in the Constitution (CRFB / 88 - Art. 5, LVII)

The media have been flaunting untruthful and non-existent facts about me, in information passed on unscrupulously by the judicial police itself, in order to tarnish my good name and my family name in a sensationalist media behavior.

But what worries me most is the well-being of my little daughter, GIULIA OLIVEIRA AMIRIDIS, born on June 12, 2006, just 10 years old, delivered by me for provisional custody, because of my sane and conscious choice, to her sponsor ROSANE MELLO BRUM, identity document number 86435385 issued by IFP / RJ and registered with the CPF under the number 011.574.057 / 03, resident at Santana Street, 473, Muriqui - City of Mangaratiba, CEP 23860-000, until my Libertarian situation is re-established.

I am embittering a temporary prison for a period of 30 (thirty) days for "mere suspicions", but I trust the Judicial Authorities of my country to review this decision even though it requires the prosecution of the case and the presentation of my arguments. For the time being I am the object of investigation and I can't even defend myself with the testimonial evidence that I possess.

However, I could not stop pleading with you to provide my daughter, also a person of Greek citizenship, who urgently needs to survive until I can definitively restore mother care, especially psychological care.

I hereby communicate that I have contracted the professional services of the Lawyers - Dr. JORGE VIANA DÓRIA, OAB / RJ 88317 , Dr. WILMAN BRAGA , OAB / RJ 198957 and Dra. REBECA MOREIRA DIAS DÓRIA, OAB/RJ 167667, both with a professional office located at Coronel Francisco Soares Street, 71, Group 202, Nova Iguaçu, Rio de Janeiro, BRAZIL –ZIP CODE 26220-010, telephones / WhatsApp (21) 96434-7510, 98597-5542 e 98308-8262, email [jvianadoria@yahoo.com.br](mailto:jvianadoria@yahoo.com.br), according to copy of the attached judicial power of attorney, for efficient resolution of criminal, administrative, civil and who are able to declare in my name information arising from all matters which the Greek Republic deems appropriate to take note of, apart from the official Government channels (Security & Justice).

In the certainty of being fully FULFILLED in my lawsuits and that my daughter thus will not be physically destitute, I subscribe this document in a single way, assisted by my lawyers and in CONFIDENTIAL.
